Rental Rates

All rates are per person (including leaders)

Overnight rate: Fri-Sat Adult, \$55.00; Youth 5-12 \$45.00

Sun-Thu Adult \$53.00; Youth 5-12 \$43.00

Day use rate: Age 0-4 free, Age 5 and up \$25.00 per day

Overnight rate includes the day use rate.

Minimum rate for an overnight is \$500; minimum group rate for day use is \$100

Groups less than 50 people may have to share the grounds with other small groups. You will be notified in advance if another group will be on the premises. For an additional fee of \$750, you may reserve the entire camp so that no other groups will be present during your stay.

Deposit

Required to confirm your reservation and will be returned within two weeks after your stay is complete, as long as the camp is clean and there is no damage.

Overnight deposit: \$500.00; day use deposit: \$100.00

Check In/Out Times

Weekend (or Multiple Days): Check in time is after 3:00 PM, check out time is before 11:00 AM.

Day Use Hours are from 6 AM to 10 PM

- For early check-ins/late check outs you will be charged for an additional day.
- It is your responsibility to leave camp as you found it.

Cancellation of overnight events is allowed with full refund only if it occurs at least 60 days before the event.

The Balance for your event as well as the head count for each days' meals is due 21 Days prior to your event. Additional fees accrued after this point may be paid upon your departure.

Pool Rental (in Season)

\$80 per hour

- Must bring own lifeguard with certificate or \$25 per hour for BH lifeguard (if available).
- There is a minimum of 1 lifeguard per 25 swimmers required.

Insurance

We ask each user group to provide us with a Certificate of Insurance. For organized groups, this form is available from your group's insurance carrier, dated specifically for each event. For family reunions, individuals or receptions, this Certificate can be obtained from your homeowners or renters insurance company of the sponsoring family.

Bethany Hills must be named as Certificate holder on the bottom of the form. Bethany Hills maintains insurance, but your insurance is considered primary.

Bethany Hills is a non-smoking facility, alcohol free environment, free from illegal drugs or activity. Firearms are not allowed. Violators will be asked to vacate the premises immediately with no refund.

Bethany Hills reserves the right to refuse service to anyone.

Bethany Hills is not responsible for any accidents which may occur on the premises.

Arbitration

This clause shall not preclude parties from seeking provisional remedies in aid of arbitration from a court of appropriate jurisdiction. Allocation of Fees and Cost: in an award the arbitrator may allocate all or part of the costs of the arbitration, including the fees of the arbitrator and the reasonable attorney fees of the prevailing party.
